- You are welcome to print the high resolution images provided to you for your personal use or as gifts only.
- You are welcome to use the images provided to you for your portfolio, your website, etc. provided credit is given to CJO Photography.
- CJO Photography retain the right to use, at my discretion, photos for advertising, marketing and promotional purposes. At all times I will use good judgement in the choice and use of photos. If you do not authorise online publication, including Facebook & website use, please check the appropriate boxes on Pg1 of this form.
- All photos have been individually processed, colour corrected and enhanced to bring the image to its full potential. All work is performed on a fully calibrated system, and prints ordered will be done by a carefully selected professional lab. All prints are quality checked before being presented to the client to ensure that they are of a high standard, both in printing and in colour.
- Prints may appear slightly different to the image displayed on a clients monitor due to variation in the client's calibration.
